SPECIAL PRESENTATION – VisionKershaw 2030

Kershaw County Chairman Julian Bums brief presentation to city council was about the revised version of VisionKershaw 2030 plan. Mr. Burns describe the plan as a "collaborative roadmap" to guide Kershaw County government, leaders, educators, businesses, non-profits, and private citizens as they work together to build vibrant communities and VisionKershaw 2030 plan as "providing the impetus" -- a guide policy -- for how we can work together with public and private sectors, nonprofits, our school district, healthcare, law enforcement, the judicial system, the faith community, our neighborhoods and volunteers.
