IX. **Ordinance #2025-009 1<sup>st</sup> Reading**

Council to consider an ordinance of the City Council of the City of Camden, South Carolina, authorizing and confirming the implementation of combined utility system rates and charges for the fiscal year beginning July 1, 2025: and other matters related thereto.

X. **Ordinance #2025-010 1<sup>st</sup> Reading**

Council to consider an ordinance of the City of Camden, South Carolina amending Title XIII, Chapter 131 of the City's Code of Ordinances to regulate the use of metal detectors on municipal property; and other matters related thereto.

XI. **Ordinance #2025-011 1<sup>st</sup> Reading**

Council to consider an ordinance approving the financing of sewer system improvements to the combined Public Utility System of the City of Camden, South Carolina, through the borrowing of not exceeding five million five hundred twenty-five thousand dollars (\$5,525,000), plus capitalized interest, if any, from the State Water Pollution control Revolving Fund, by agreement with the South Carolina Water Quality Revolving Fund Authority, pursuant to Title 48, Chapter 5, Code of Laws of South Carolina 1976, as amended; providing for the agreement to make and to accept a loan, the execution and delivery of a loan agreement between the City of Camden, South Carolina and the South Carolina water Quality Revolving Fund Authority, the execution and delivery of a promissory Note from the City of Camden, South Carolina to the South Carolina Water Quality Revolving Fund Authority; and other matters relating thereto.
