CALL TO ORDER

Mayor Vincent Sheheen called the Camden City Council Meeting to order at 5:30 p.m.

INVOCATION

Councilmember Phil Elliott opened the council meeting with the invocation.

APPROVAL OF MINUTES

Council, on motion by Councilmember Wilkes, seconded by Mayor Pro Tem Boykin, voted unanimously to approve the regular meeting minutes of October 21, 2025.

APPROVAL OF PROPOSED AGENDA

Council, on motion by Councilmember Davis, seconded by Mayor Pro Tem Boykin, voted unanimously to approve the November 18, 2025 proposed agenda.

PUBLIC COMMENTS

<u>William Browning</u> expressed his thanks to the City of Camden and to all individuals and departments whose guidance and support contributed to the success of the 2025 DockDogs event. <u>Joanna B. Craig</u> spoke proudly about Camden's rich history, its historic homes and its distinctive architecture. ORDINANCE #2025-034 2nd Reading

Council on motion by Mayor Pro Tem Boykin, second by Councilmember Wilkes, voted unanimously to approve an ordinance amending section 71.16 of title VII in the City of Camden Code of Ordinances; and other matters relating thereto; (update to truck route ordinance to align signage with ordinance verbiage)

ORDINANCE #2025-035 2nd Reading

Council on motion by Councilmember Wilkes, second by Councilmember Davis, voted unanimously to approve an ordinance to authorize the granting of an easement by the City of Camden to Camden Rutledge properties, LLC. (Property located at 511 Rutledge Street)

ORDINANCE #2025-036 1st Reading

Council on motion by Councilmember Wilkes, second by Councilmember Elliott, voted to approve the following amendments to an ordinance to amending Title XIII, Chapters 130, 131, and 133, of the City of Camden Code of Ordinance pertaining to general offenses: deleting Title XIII, Chapter 132, 134, and 135 in their entirety; and other matters related thereto.

Amendments to Section 130.04 Begging

- (7) Beg within 50 feet of any outdoor dining area or outdoor merchandise area.
- (10) Beg while the person being solicited is in a vehicle.
- (11) Beg after dark.
- Add the following sentence:
 - o (12) Beg at a traffic intersection, which causes drivers to be distracted.

Council on motion by Councilmember Wilkes, second by Mayor Pro Tem Boykin, voted to approve the following amendments to Ordinance #2025-036:

Amendments to Section 130.01 Begging

- (6) Beg within 50 feet of the entrance to any financial institution or any automated teller machine, regardless of whether or not such automate teller machine is located at or near a financial institution.
- (8) Beg within 50 feet of any transit stop or shelter or taxi stand.



Discussion was held to revise Chapter 133: Weapons Control - Section 133.01 (B) (ii) **prior** to 2^{nd} reading of the ordinance.

Council motion by Mayor Pro Tem Boykin, seconded by Councilmember Davis, voted unanimously to approve ordinance #2025-036, as amended.

ORDINANCE #2025-037 1st Reading

Council on motion by Councilmember Wilkes, second by Councilmember Elliott, voted unanimously to approve an ordinance approving an application for Special Property Tax Assessment for historic property; and other matters related thereto. (*Property located at 1038 Broad Street*)

RESOLUTION #2025-027

Council on motion by Mayor Pro Tem Boykin, second by Councilmember Davis, voted unanimously to approve a Resolution authorizing certain amendments to the Financial Policies for the Combined Utility System of the City of Camden, South Carolina and other matters relating thereto.
